Food Vendors	8% of Sales or \$8 minimum, whichever is GREATER
Crafters / Artisans	10% of Sales or \$15 minimum, whichever is GREATER
Other Vendor	10% of Sales or \$15 minimum, whichever is GREATER
Services	to be determined by the Board and Market Manager

All Vendor are required to pay the State of California Dept. of Agriculture 'Weekly Vendor Fee' of \$2 and Certified Growers must pay the Fee of \$2 per Certificate. Shared booth space is \$2 for each.

Upfront Deposit: \$40 is collected from each new Vendor and held for 4 consecutive Saturdays. The amount will be refunded on the 5th Saturday. If the vendor leaves before, the amount is forfeited to the market.
